Passport Books (U.S. Citizens)

- Suggest applying for Passport by August 01, 2022 (Routine processing time is 10 12 weeks)
- Must be valid for the duration of your stay in the Republic of Ireland (At least three months
 remaining validity after your departure date from Ireland is strongly recommended)
- Non-US Citizens are required to inquire with their respective government passport agencies, embassy, or consulate regarding the validity of their passport traveling to the UK & Ireland and are responsible for any required Visas (and associated fees)

COVID-19

Effective 19 July 2021, Ireland is welcoming travelers from the U.S. who have valid proof of vaccination. Travelers must also complete an electronic COVID-19 Passenger Locator Form (PLF) prior to departing the U.S. for Ireland. In addition, the U.S. requires a COVID test within 72 hours of arrival back into U.S. (*Details & Requirements are subject to change*)
